



First Grade Field Trip
to
Liuzza Farms
in
Amite, Louisiana

Madisonville Elementary first grade students will be going on a field trip to Liuzza Farms in Amite, Louisiana to get an up close look at farm produce going from the farm to the local grocery. Students will have a guided wagon tour, visit baby farm animals, feed baby calves, plant and pick vegetables.

If you would like to attend as a chaperone, a \$7.00 admission fee and a chaperone responsibility form must be filled out and returned to school before the deadline. On the morning of the field trip you must check-in at the school office with your driver's license to receive a chaperone pass. Liuzza Farms has implemented a new chaperone procedure. If you are not signed up to chaperone by the deadline you will not be allowed admission into the facility. There will be **NO** exceptions. Once signed in, you may leave for Liuzza Farms and meet the students at the admissions office. You will need to provide an ID for admission at Liuzza Farms as they will check your name off the list. For the safety of our children, no students will be dismissed from Liuzza Farms. If it's a cool morning, please send a light jacket with your child (be sure name is on clothing). If you wish, you may apply sunscreen before leaving home. No one will be able to chaperone without a school pass including chaperoning your own child. **If you arrive without the proper credentials at Liuzza's you will not be admitted.**

Chaperones NOT signed-up by the deadline will not be allowed to sign-in as a chaperone. No one will be allowed to register as a chaperone the morning of a field trip.
